FYUSION IMAGING ADDITIONAL TERMS

These Additional Terms supplement the Master Agreement located at https://www.coxautoinc.com/terms/usa, and apply with respect to the Cox Product covered by these Additional Terms.

Product Description: "**Fyusion Imaging**" is a Cox Data Product that enables submitting vehicle image content for enhancement through a proprietary Fyusion process, generating an enhanced image while returning a unique identifier that enables subsequent retrieval of such enhanced image on a proprietary Fyusion viewer. Fyusion, Inc. ("**Fyusion**"), an Affiliate of Cox, may own certain rights or provide certain services relating to Fyusion Imaging.

Additional Terms:

- 1. **Definitions**. Capitalized terms used, but not otherwise defined, herein shall have the meanings ascribed to them in the Master Agreement. In addition, for the purposes of these Additional Terms, the following terms shall have the following meanings:
 - (a) "API" means application program interface of Cox designed to receive Customer's call and return Session ID in response to such call.
 - (b) "Cox Data Output" means, for the purposes of these Additional Terms, the Fyusion Images accessible through Fyusion Imaging.
 - (c) "Customer Platform" means any website, application or other product of Customer intending to make use of Cox Data Output.
 - (d) "Fyusion Image" means a proprietary enhanced image or video generated by Fyusion Imaging.
 - (e) "Session ID" a unique identifier generated upon creation of a Fyusion Image.

2. **Delivery**.

- (a) The Session ID will be made available to Customer via an API or such other reasonable electronic transmittal method as Cox may designate to Customer from time to time, in its discretion, during the Subscription Term.
- (b) A Fyusion Image will be delivered in response to a query with a Session ID via a Fyusion viewer made available from time to time by Cox. It shall be Customer's responsibility to assure integration and compatibility of the Customer Platform with the Fyusion viewer.

3. Conditions Applicable to All Permitted Uses.

(a) Customer represents and warrants that each API call to create a Session ID shall be made only with true and actual images of a vehicle for which Customer is a seller of record and which is currently being listed on a Customer Platform identified in the applicable Permitted Use. A Fyusion Image shall be accessible for up to 90 days from generation; provided that it shall be Customer's sole responsibility at all times to verify and monitor that an image accurately represents the vehicle condition.

- (b) License to Cox Data Output hereunder is limited to viewing the Fyusion Image accessible with the applicable Session ID and excludes copying, downloading, storing or transmitting Cox Data Output. Customer shall not (and shall not share a Session ID with any Third Party that results in) violation of these Additional Terms or any terms of the Master Agreement.
- (c) The software development kit (SDK) provided to Customer shall be used for the sole purpose of generating a Session ID and shall not be copied, reverse-engineered, transferred or modified. The SDK constitutes "materials" for the purposes of Section 3.2(a) of the Master Agreement that shall be promptly deleted by Customer (and such deletion certified to Cox) upon termination of Subscription to Fyusion Imaging.
