
KELLEY BLUE BOOK PRICING SERVICE **DISPLAY REQUIREMENTS**

These Display Requirements govern the display of Valuations on consumer-facing Website(s).

Kelley Approval for All Displays is REQUIRED. Prior to the use, release or distribution, Kelley shall approve in writing any and all displays that include the information below. At any time during the Term, Kelley may request to review such Display.

I.	Generating a Valuation. With respect to the Kelley Blue Book Values, all information required to generate a
	Valuation must be collected from the Licensee Site user prior to its display. This minimum requirement of

- II. Displaying Valuations on Customer Website(s). The page that displays a Valuation on the Customer Website must contain the following required elements:
 - A. Identify the displayed value as 'Kelley Blue Book® <specific value type> Value" or "Blue Book® <specific value type> Value"
 - **B.** The date the Valuation was generated.
 - **C.** The Province as entered by the visitor.
 - **D.** A description of the vehicle which must include the following information:
 - 1. Year
 - 2. Make
 - 3. Model
 - 4. Trim
 - Engine
 - 6. Transmission
 - 7. Drivetrain
 - 8. Kilometers
 - 9. All optional equipment selected by the visitor
 - E. A Kelley Mark, which shall be no smaller than 50x50 pixels. Kelley Marks are available here and are subject to the accompanying Kelley Blue Book Downloadable Trademark Usage Guidelines.

NEW VEHICLES

MSRP

The MSRP, or Manufacturer's Suggested Retail Price, is the price set by the manufacturer. MSRP includes destination charges and minimum required equipment, but excludes service and handling fees, discounts, taxes, insurance, license, and registration fees. MSRP is a reference point for negotiations, however dealers can choose to sell a vehicle above or below its listed MSRP.

Invoice

The Invoice price is the price the manufacturer charges its dealers for a new vehicle, but it does not necessarily reflect the total price actually paid by the dealer for the vehicle. The Invoice price includes destination charges, but doesn't include dealer advertising costs or costs for selling, preparing, displaying or financing the vehicle. Also, Invoice price does not include factory-to-dealer incentives and other factors which can reduce what the dealer pays for the vehicle.

Kelley Blue Book® Fair Purchase Price (New)

Updated monthly, the Kelley Blue Book® Fair Purchase Price for new cars is generally the midpoint of the Kelley Blue Book® Fair Market Range. It is Kelley Blue Book's estimate of what a consumer can reasonably expect to pay this month for a new vehicle configured with their selected options, excluding taxes, licensing, registration, fees and any available rebates or incentives. It's based on actual new-car transactions, plus data from other reliable third-party sources as well as market conditions.

Kelley Blue Book® Fair Market Range (New)

The Kelley Blue Book® Fair Market Range for new cars is Kelley Blue Book's estimate of what a consumer can reasonably expect to pay this month for a vehicle configured with their selected options, excluding taxes, licensing, registration, fees and any available rebates or incentives. Each dealer sets and controls its own pricing.

Kelley Blue Book® Private Party Value

Kelley Blue Book® Fair Market Range (Private Party)

The Kelley Blue Book® Fair Market Range (Private Party) is Kelley Blue Book's estimate of the price range of what a consumer can reasonably expect to receive this month for a vehicle with stated kilometers in the selected condition and configured with their selected options, excluding taxes, license, registration, and fees when selling to a private party.

Kelley Blue Book® Fair Purchase Price (Used)

Updated monthly, the Kelley Blue Book® Fair Purchase Price for used cars is generally the midpoint of the Kelley Blue Book® Fair Market Range. It is Kelley Blue Book's estimate of what a consumer can reasonably expect to pay for this year, make and model used vehicle with typical kilometers and configured with their selected options, excluding taxes, licensing, registration and fees, when buying from a dealer. It's based on actual used-car transactions, plus data from other reliable third-party sources as well as market conditions.

Kelley Blue Book® Fair Market Range (Used)

Updated monthly, the Kelley Blue Book® Fair Market Range for used cars is Kelley Blue Book's estimate of what a consumer can reasonably expect to pay for this year, make and model used vehicle with typical kilometers and configured with their selected options, excluding taxes, licensing, registration, and fees, when buying from a dealer. Please note, regardless of the Kelley Blue Book Fair Market Range, each dealer sets and controls its own pricing.

Kelley Blue Book® Trade-In Value

Updated monthly, the Kelley Blue Book® Trade-In Value is Kelley Blue Book's estimate of what a consumer can expect to receive from a dealer for a trade-in vehicle assuming an accurate appraisal of condition. This value will likely be less than the Private Party Value because the reselling dealer incurs the cost of safety inspections, reconditioning and other costs of doing business.

Kelley Blue Book® Trade-In Range

Updated monthly, the Kelley Blue Book® Trade-In Range is Kelley Blue Book's estimate of what a consumer can expect to receive this month based on the style, condition, kilometers and options of the vehicle when they trade it in to a dealer. However, every dealer is different and values are not guaranteed.

H. When displaying a Kelley Blue Book Trade-In Value or Private Party Value, the vehicle condition definition must be displayed, as provided below, in at least 9-point font near or in roll-over format as approved by Cox:

Excellent

"Excellent" condition means that the vehicle looks new and is in excellent mechanical condition. This vehicle has never had any paint touch-ups and/or bodywork and does not need reconditioning. The engine compartment is clean and free of leaks. This vehicle is free of rust. The body and interior are free of wear or visible defects. The wheels are flawless and the tires all match and are like new. This vehicle has a clean vehicle history report and will pass a safety inspection. This vehicle has complete and verifiable service records.

Kelley Blue Book does not rate the condition of the vehicle. Rating the vehicle is the exclusive responsibility of the user. The condition descriptions are provided to guide in the assessment of vehicles.

Very Good

"Very Good" condition means that the vehicle has minor cosmetic defects and is in excellent mechanical condition. This vehicle has had minor paint touch-ups and/or bodywork, and requires minimal reconditioning. The engine compartment is clean and free of leaks. This vehicle is free of rust. The

body and interior have minimal signs of wear or visible defects. The tires all match and have 75% or more of tread remaining. This vehicle has a clean vehicle history report and will pass a safety inspection. Most service records are available.

Kelley Blue Book does not rate the condition of the vehicle. Rating the vehicle is the exclusive responsibility of the user. The condition descriptions are provided to guide in the assessment of vehicles.

Good

"Good" condition means that the vehicle has some minor cosmetic repairable defects and is free of mechanical problems. This vehicle has had minor paint touch-ups and/or bodywork. The engine compartment may have minor leaks. This vehicle has only minor rust, if any. The body and interior have normal signs of wear or visible defects. The wheels may have minor repairable scratches or scrapes. All tires match and have at least 50% or more tread remaining. This vehicle has a clean vehicle history report and will pass a safety inspection. Most service records are available.

Kelley Blue Book does not rate the condition of the vehicle. Rating the vehicle is the exclusive responsibility of the user. The condition descriptions are provided to guide in the assessment of vehicles.

Fair

"Fair" condition means that the vehicle has cosmetic defects that require repairing and/or replacing and may require minimal mechanical maintenance. This vehicle may need some mechanical repairs. The paint and bodywork may require refinishing and body repair. The engine compartment has leaks and may require minimal repairs. This vehicle may have some repairable rust damage. The body has dings, chips, and/ or scratches and the interior has substantial wear, and may have small tears. The wheels may be warped or bent, have scratches and might require replacement and tires may need replacing. This vehicle needs servicing, but is still in reasonable running condition. Few service records available.

IV. Miscellaneous.

- **A.** Each page of the path to the report page for a Valuation must contain a Kelley Mark, the use, display and positioning must be pre-approved by Cox.
- **B.** Optional equipment for which Kelley has not assigned a value may not be added to the vehicle valuation. If such optional equipment needs to be added (e.g., for convenience of introducing additional information on a vehicle in a classified listing), then the valuation provided to the consumer must make it clear that such optional equipment was not included in the overall vehicle valuation.
- **C.** All Blue Book® Values displayed on Customer Website(s) must match the then-current values generated and provided by KBB for vehicles with the same optional equipment.
- **D.** All usage of Kelley Marks must comply with the terms and conditions of the Agreement, and the Kelley Blue Book Downloadable Trademark Usage Guidelines here which may be changed by Cox at its sole discretion.
