KELLEY BLUE BOOK INFODRIVER CONSUMER-FACING WEBSITE ADDITIONAL TERMS

The terms and conditions set forth in these Additional Terms are in addition to the terms and conditions set forth in the Master Data License (<u>https://www.coxautoinc.com/terms/wp-content/uploads/sites/3/Master-Data-License-Agreement.pdf</u>), and apply with respect to the Licensed Data covered by these Additional Terms. Capitalized terms used, but not otherwise defined, herein shall have the meanings given to them in the Master Data License. For the purposes of these Additional Terms, "Kelley Blue Book Co., Inc." an Affiliate of Cox Automotive, Inc. shall be considered "CAI" and any reference to "KBB" or "Kelley Blue Book" shall be deemed a reference to CAI for the purposes of the Master Data License.

<u>Product Descriptions</u>: The Kelley Blue Book InfoDriver Web Service (*"InfoDriver"*) is a Cox Product that Licensee can use to call and access certain Kelley Blue Book vehicle pricing and specifications information.

Additional Terms and Conditions:

- 1. Definitions.
 - (a) "Display Requirements" means the Licensed Data, and KBB Marks display requirements for the Licensee Website(s), which can be found at the following link: <u>https://www.coxautoinc.com/wp-content/uploads/sites/3/Kelley-Blue-Book-INFODRIVER-Display-Requirements.pdf</u>, as may be amended by Kelley Blue Book from time to time upon written notice to Licensee.
 - (b) *"KBB Competitor"* means Edmunds.com, J.D. Power and Associates, NADA Appraisal Guides, Inc. (nadaguides.com), the Black Book division of National Auto Research (blackbookusa.com), TrueCar.com, or any other Third Party that provides editorialized vehicle pricing data.
 - (c) *"KBB Content"* means, individually or collectively, the consumer ratings, consumer reviews, expert ratings, expert reviews, articles, and other content, provided by Kelley Blue Book.
 - (d) **"KBB Data"** means the new and used vehicle pricing, specifications, Valuations and/or other information delivered from time to time by Kelley Blue Book or its Affiliates via InfoDriver, as set forth in the applicable Order Form.
 - (e) "*KBB Marks*" means any name, logo, trademark or service mark of Kelley Blue Book, including but not limited to "Kelley Blue Book," "Blue Book," "KBB.com," any variations or misspellings thereof, and the Kelley Blue Book logo.
 - (f) *"Licensed Data"* means individually or collectively, the 1) the KBB Content; and/or 2) the KBB Data (including Valuations, as defined below) as specified in an Order Form.
 - (g) *"Licensee Website(s)"* means any website and/or application that is specified on the Order Form that Licensee owns, manages, or controls, and is accessed by the general public (i.e., consumers).
 - (h) "Valuation" means a single price or value, or a range of prices or values from the KBB Data for a specific vehicle identified by a VIN or configuration (i.e., year, make, model, trim, optional equipment, and mileage) for a specific geographic zone (i.e., zip code) for a specific date.
 - (i) *"Visitor"* means any visitor to the Licensee Website who obtains a Valuation or Licensed Data.

2. InfoDriver and Licensed Data.

- (a) <u>Permitted Use</u>. Unless otherwise provided for in any Order Form, Licensee may use InfoDriver and the Licensed Data only to display the following on Licensee Websites: (i) KBB Data; (ii) Valuations; and/or (iii) KBB Content; in each case, in compliance with the Display Requirement. In addition, Licensee may display Valuations solely for use by Visitors to the Licensee Websites, and use and display KBB Marks, as provided by Kelley Blue Book, in connection with the Licensed Data on the Licensee Websites, subject to Kelley Blue Book's prior approval, which may be withheld or conditioned in Kelley Blue Book's sole discretion.
- (b) <u>Restrictions</u>. Licensee shall not: (i) modify, edit, or otherwise change any of the Licensed Data; (ii) publish or otherwise provide the Kelley Blue Book Auction Value or the Kelley Blue Book Lending Value on Licensee Website or any other website, application or platform; (iii) display, publish, provide access to, or otherwise provide the Licensed Data to any KBB Competitor; (iv) provide direct access to InfoDriver to any Visitor or KBB Competitor, or (v) use the KBB Marks in any manner other than as provided for in Section 2(a) herein. Restricted uses of the KBB Marks include, but are not limited to, use in any advertising creative, any search engine marketing campaign (e.g., Google AdWords) or site optimization activities (e.g., within page meta data, meta tags, webpage titles, URLs, or sub-domain URLs).
- (c) <u>Delivery</u>. Kelley Blue Book will provide the Licensed Data and KBB Marks to Licensee via InfoDriver excluding articles which shall be delivered via email.
- 3. Licensee Obligations.
 - (a) Licensee acknowledges that Kelley Blue Book may make changes to the Licensed Data or InfoDriver from time to time, which may require Licensee to modify the Licensee Website to properly display the Licensed Data. Any modifications required to the Licensee Website shall be the sole responsibility of Licensee.
 - (b) Prior to its distribution, Licensee must obtain Kelley Blue Book's approval, which may be withheld or conditioned in Kelley Blue Book's sole discretion, for the use and display of the Licensed Data and KBB Marks in the Licensee Website and/or advertising and marketing materials.
 - (c) The Licensed Data shall be provided to Visitors free of charge.
 - (d) Licensee shall place one or more graphic or text links from Licensee Website to KBB.com that are visible to search engines.
 - (e) Licensee is responsible for any and all activities that occur in connection with the Licensee Website.
 - (f) Licensee will be responsible and liable for all actions taken by Visitors in connection with the use of any Licensed Data.
 - (g) Licensee is responsible for setting up the Licensee Websites to integrate the Licensed Data Content to allow for display on Licensee Websites.
 - (h) Licensee Websites must integrate the Licensed Data by means of an HTML frame or similar technology that is approved by Kelley Blue Book in its sole discretion. Neither the KBB Data nor the KBB Content shall be presented in a pop-up, overlay, or similar device, or in a non-framed webpage.

- (i) Licensee will ensure that the Licensee Websites contain a privacy statement which includes that information about visitors may be collected and/or aggregated through the use of automated means and that all such information may be shared with Third Parties.
- (j) Except as provided herein, Licensee shall not post or otherwise make accessible any Licensed Data on any website owned, managed, controlled, or licensed by Licensee.
- (k) Licensee shall notify Kelley Blue Book immediately of any known or suspected unauthorized use of InfoDriver or of any Licensed Data, or any breach of security.
- Disclaimer and Copyright Notice. All Licensed Data displayed in the Licensee Website shall be accompanied by appropriate copyright and disclaimer notices and otherwise in accordance with the Display Requirements.
- (m) Licensee may display on Licensee Website the KBB Content related to a specific vehicle (year, make and model) once on a research page, and once on a vehicle listing page, provided the vehicles on those pages match the specific vehicle (year, make and model) referenced in the KBB Content; excluding advice articles which may appear only once on Licensee Website.
- (n) Licensee will provide hyperlinks from the KBB Content on Licensee Website directly (i.e., without intermediate pages, advertisements or re-routes) to the corresponding reviews and/or ratings content on kbb.com, in accordance with the specifications set forth in the Display Requirements.
- (o) Licensee will be responsible for updating the Licensed Data on Licensee Website at least once per week.
- 4. <u>Exclusivity</u>. Licensee shall not display within any Licensee Website, any vehicle pricing, valuation data, vehicle editorial content or advertisement of a KBB Competitor.
- 5. <u>Audit</u>. In addition to Section 8.2 of the Master Data License, at any time during the Subscription Term, Kelley Blue Book may review Licensee's use of the Licensed Data and/or the KBB Marks, including but not limited to, in the Licensee Website and/or in advertising and marketing materials, to determine compliance with these Additional Terms. Without limiting any of its other rights or remedies, if Kelley Blue Book, in its sole discretion, determines that the KBB Marks, Valuations or other elements of the Licensed Data are not properly displayed in the Licensee Website and/or advertising and marketing materials, Kelley Blue Book may, in its sole discretion, provide Licensee with an opportunity to cure the breach or exercise its suspension or termination rights set forth in Section 6 below.
- 6. <u>Suspension or Termination</u>. In addition to Section 4.4 of the Master Data License, Kelley Blue Book may suspend or terminate Licensee's Subscription to InfoDriver at any time if Kelley Blue Book reasonably determines that Licensee or its Personnel is using InfoDriver, the KBB Marks, and/or the KBB Licensed Data in breach of these Additional Terms (including any Attachments) or otherwise in an unsuitable manner.
- 7. <u>Indemnification</u>. In addition to Licensee's indemnifications set forth in Section 9.1 of the Master Data License, Licensee will indemnify and defend Kelley Blue Book and its Affiliates against any damages, losses, costs and expenses (including reasonable attorneys' fees, court costs, settlement costs and awarded amounts) incurred in connection with any Third Party claim to the extent that such claim arises from: (a) any content or advertising on Licensee Websites, any advertising, and/or any materials to which users can link through any such advertising, or (b) Licensee's breach of the obligations set forth in Section 3 above.
