

Wholesale Trends Starting Fairly Normal



- ➤ Wholesale values decreased a bit in the first part of January, falling a little more than we typically see early in the year. With only two weeks of data, we will see what the rest of the month brings.
- ➤ Days Supply grew into year end and started a bit higher than the last couple of years so far in 2024, on cue with recent weekly trends.
- ➤ Used retail prices have seen some declines early this year, across the board in terms of age/model year.
- ➤ The Weather Mother Nature has impacted the majority of the United States this week and that caused Manheim to move to digital sales at many locations which will impact us over the next several weeks.


January Mid-Month MUVVI

Mid-January 2024






January MUVVI Changes by Segment



Early 2024 declines are higher for Sedans & Pickups while EV's show much higher Y/Y depreciation




Wholesale Supply Slowly Increasing

Wholesale Days of Supply




Used Retail & Wholesale Prices

3YO Retail and Wholesale Price Indices




Summary
